Ensure the property has proper approvals and paperwork.

MONTHLY RENT & DUE DATE:

LEASE DURATION & NOTICE PERIOD:

Define the contract length and exit terms.

MAINTENANCE RESPONSIBILITIES:

Clarify whether repair costs are the tenant's or landlord's responsibility.

Always check all terms before signing.

Ignoring Hidden Costs:

Maintenance charges, utility bills, and parking fees.

Report any damages before moving in.
